ORDER

At a session of said Court held at the Courthouse in the City of Stanton, in said County and State, on the 15th day of December, 1983.

PRESENT: Hon. Charles W. Simon, Jr. Circuit Judge

This matter having been brought on for hearing upon the petition of Bruce E. Basom, Prosecuting Attorney for the County of Montcalm, for and in behalf of the Montcalm County Board of Commissioners, praying for the establishment of a Special Assessment District and other matters relating to the maintenance of the Court established lake level of Crystal Lake in Crystal Township, and the Court having heard oral testimony and received into evidence maps of the proposed Special Assessment District, and a position statement from the Water Management Division of the Michigan Department of Natural Resources concerning the same, and the Court otherwise being fully advised in the premises;

IT IS ORDERED, ADJUDGED AND DECREED, that the Special Assessment District as proposed in the aforementioned petition be and hereby is established for Crystal Lake in Crystal Township. (See Exhibit A)

orders of this Court dated August 29, 1932, and July 23, 1962, regarding the establishment and maintenance of the lake level of Crystal Lake in Crystal Township at 800.49 feet above sea level during the summer months and 799.49 feet above sea level during other months remain in full force and effect subject to the following modifications:

(1) the Montcalm County Drain Commissioner or his successor(s) in interest shall be custodian of the plank (1983 in

the sluiceway of Crystal Lake, Crystal Township, said plank(s) being the mechanism(s) used to maintain the Court ordered lake level;

- (2) the Montcalm County Drain Commissioner or his successor(s) in interest shall replace the single twelve-inch plank with three four-inch planks, said planks to be placed in the sluiceway on April first of each year and removed at his discretion between September fifteenth and December first of each year in a matter to best facilitate the orderly discharge of water from Crystal Lake into Swan (formerly Mud) Lake;
- (3) that the benchmark (monument) placed in Crystal Lake by J. W. Harrod, Civil Engineer, on the twenty-first day of October, 1932, said benchmark showing the natural level of said lake, be moved in a manner consistent with the aforementioned Court established lake level and be made a permanent part of the sluiceway control structure or otherwise repaired in a manner that will ensure the permanency of the benchmark against the forces of nature which have over the years caused it to be moved from its original placement point;
- (4) that a large tree located downstream from the sluiceway connecting Crystal Lake and Swan (formerly Mud) Lake as depicted in exhibit six (6) from the hearing on said petition shall be removed, as said tree serves as an impediment to the orderly discharge of water between the two lakes;
- (5) that said maintenance and repair previously discussed shall be completed as efficiently and expeditiously as possible.
