### SAFE BOATING PROGRAM OFFERS SUMMER ADVENTURE

July 21 and 22 were the scheduled dates for the Crystal Lake Association Boater Safety Program. The CLA, Crystal Sailing Club and the Montcalm Sheriffs Department offered youth ages 12 and up the opportunity to have Boater Safety Training in a setting other than the usual classroom.

The pre-registered group consisted of 11 to 18 year old youths, whom were joined by parents and grandparents. Montcalm County Sheriff Deputies, Stephanie Clark, Lynn Hunt and Josh Patino were the officers in charge of the Boater Safety Training. Officers Hunt and Patino are the Crystal Lake Marine Patrol. The Boston Whaler and another Sheriff's Department Boat where brought to the training site at the Crystal Sailing Club. Officer Clark taught the text to the attendees inside the Sailing Club, explaining the 2002

Boating laws, relative to motorized water craft as well as non-motorized craft such as sail boats. Officers Hunt and Patino then boarded the youth in the two boats and took them out unto the lake in groups of 3-5 youth. They explained safe and unsafe boating practices and emphasized what had been taught in the classroom. Students had to answer a certain % of questions correctly after the second day of training in order to obtain their Safe Boating Certificate signed. All in all 26 attendees received Certification.
