New news on the trash compactor

Just like everyone else, I am also anxiously waiting for this project to show more signs of progress. The township had already approved \$5,000 months ago to help in developing the plan. At this point the location for the new compactor will be at the current recycling location due to the availability of the required 3 phase power. The current recycle bins will be relocated across the parking lot until the compactor is installed. There is potential for surveillance cameras at the site as well to hopefully quell the desire to leave old grills and or mattresses deemed NOT recyclable!! There may have to be some upgrading for a concrete pad at that site but as of now the plans are still being reviewed by Republic Sanitation Services and Consumers Energy. A new and improved recycling center is right around the corner, but in the mean time lets do our part in

keeping our recycling area nice and neat.

The Missing Money.... \$1000

It's still a mystery! As of the last township meeting in August it was disclosed that the investigation was closed with no one being charged with any crime. There were multiple people questioned and some submitting results from lie detector tests that proved their innocence but still resulting in no new leads or evidence. I would recommend reading two Daily News articles that explicitly describe the chain of events: "Crystal Township theft investigation closed, no charges filed", and the other article dated August 15th, "Crystal Township Board looks into internal controls study" that details further audit discrepancies and corrective action plan recommendations over the course of the last ten years. I will update you in the Spring Newsletter about our progress. Since the Spring Newsletter does not come out until we are well into Egg Maintenance, I would also like to remind you of ways you can help long distance next spring:

- **1. Be observant** around your cottages and note any spots that you observe nesting potential. Geolocate or just mark it on a map and get the information to me. We will use this information next year.
- **2. Stop by the lake** in early spring and take a walk around your area and note any evidence of nesting geese.
- **3. Encourage your neighbors** to do the same.
- **4. If you have not already, join CLA** (and encourage your neighbors to do the same).
- **5. Give us permission to canvas your property** in your absence. (a letter, text or email sent to us is sufficient or use the permission slip included in this newsletter).

Know Your LAKE

What is Eurasian Water Milfoil?

Eurasian Water Milfoil is an invasive aquatic plant that can cause significant problems for freshwater lakes. It is native to Europe and Asia but has become a problem in the United States. Milfoil grows underwater on the lakebed. It can outcompete our natural aquatic plants, forming dense mats that make it difficult for fish to feed, swim, and reproduce. If left untreated it will also reduce the oxygen levels in the lake, leading to poor water quality and fish kills. It can grow and spread very fast, so ongoing monitoring and treatment are essential.

Water Quality - Fall 2023

Our lake remained healthy this summer, but it required ongoing monitoring and investment. Our Spring survey, as reported in the previous newsletter, found 13 acres of Eurasian Water Milfoil (EWM), which was treated with a total cost of \$13,000, including the survey.

In July, we had a second survey performed by Restorative Lake Sciences. The second survey found an additional 9 acres of EWM, and 1 acre of Starry Stonewort (SSW). Both of these invasive species are a major concern, and if left untreated can cause irreparable, long-term, damage to our lake. The additional growth found in the second survey was likely related to last year's mild winter. We had less ice, and also less snow on the ice. This means more light to enable survival of the weeds and seed beds. In July, we had a second treatment performed for both species at a cost of \$7,900, which should drive levels down as we enter Winter.

Throughout the summer we also monitor lake clarity, and we take samples for the DNR to assess chlorophyll levels and phosphorus levels. Our lake clarity over the summer was good and remained similar to past years. Our Spring phosphorus reading was 5 parts per billion, which is a very healthy level. High phosphorus levels are warning signs of excessive weed growth that can lead to lake death. We will be

taking final samples for both chlorophyll and phosphorus in September and will receive the DNR report summarizing all of the data later this year.

It is very important that we continue our monitoring, surveys, and treatments to ensure that invasive species are controlled and that our lake is healthy. This is one of the most important missions of the CLA. We appreciate your support!
